Terms and conditions:-

- Age :-** Candidate must not be less than 18 years of age and not more than 40 years of age as on 01-01-2020. The upper age limit is relaxable for candidates belonging to SC/ST categories upto 45 years ; for candidates belonging to OBC/MOBC categories upto 43 years ; for candidates belonging to ex-Servicemen category upto 42 years and for candidates belonging to Persons with Disabilities category upto 50 years as per Govt. OM No.ABP.06/2016/51; dated 02/09/2020 issued by the government of Assam in Personnel(B) Department.
- Educational qualification:-**
 - The minimum educational qualification of candidates for the post of Driver is H.S.L.C. or equivalent examination passed from a recognized institute of the State /Central Govt. and must possess valid driving license issued by competent authority.
- Applicants must upload the following documents/ testimonials along with the application:-**
 - One recent passport size photograph.
 - Specimen Signature
 - Admit Card/Pass Certificate & mark sheet of HSLC Examination .
 - Valid driving license issued by competent authority.
 - Caste certificate(If applicable)

- Candidates already in government service should apply through proper channel.
- Candidates whose applications are accepted as per eligibility criteria will be required to appear in a Written Examination and Driving Test .Selection will be strictly on the basis of merit.
- Incomplete applications will be rejected.**
- The selection committee shall have the right to accept or reject the candidature of a candidate after proper scrutiny of the documents/testimonials etc. with regards to the modalities of selections. The decision of the selection committee shall be final and binding. The selected candidates will have to submit an undertaking to the appointing authority that they will abide by the new pension rules issued by the Government of Assam in Finance Department vide No.BW.03/2003/Pt-I/1; Date:25/01/2005.
